



MEMORANDUM OF UNDERSTANDING

between

Faculty of Law, Sriwijaya University, Indonesia

And

Faculty of Law, Chiang Mai University, Thailand

The Faculty of Law of Sriwijaya University, represented by its Dean and the Faculty of Law Chiang Mai University, represented by Dean Faculty of Law Chiang Mai University, shall hereinafter be referred to singularly as "the Party" and jointly as "the Parties".

THE PARTIES HEREBY AGREE AS FOLLOWS:

- 1. Both parties promote collaboration and .to strengthen friendly relationships between the institutions.
- 2. The main objective will be collaboration in the field of law as well as the administrative systems which are compatible with orientation of each party.
- 3. Both parties will implement the following subjects for collaboration on the basis of equality and reciprocity
 - a) Exchange of faculties, staffs, managers, clerks, and students
 - b) Exchange of publications and information
 - c) Coordination of relevant research projects and academic services activities.
 - d) Exchange of pertinent know-hows and technologies
- 4. In order to be effective in the subject of cooperation, representatives of both parties will be encouraged to consult each other and develop specific plans for collaboration in any or all ways mentioned above. There is a possibility that several resources, including financial ones, will be limited in spite of the efforts by both institutions.

- a) Each party reserves the right to approve the candidate proposed for the exchange by the other institution.
- b) Both parties will jointly seek financial resources for covering the cost of the exchange programme.
- c) Each institution will endeavour to raise funds for travel to host party for their faculty, administrative officers and clerks or students wishing to participate in the exchange.
- d) The host institution will assist visiting faculty, administrative officer and clerks or students to find accommodation and to become integrated into their new social environment. Both will try to find resources to help more students to visit the counterpart institution.
- e) The host institution will provide suitable working and studying space for visiting bodies and provide secretarial services.
- f) Both parties will address their Embassies in the counterpart Country in order to try to obtain any possible support to fulfill this Memorandum of Agreement.
- 5. This agreement will come into effect on the date when the representatives of both parties affix their signatures to the agreement and shall be valid for the period of five years. The agreement is renewable if it is the wish of both parties and may be revised or modified at any time more than 6 months prior to the expiration of the foregoing period by mutual consent.
- 6. The official agreement forms are filled with and signed in English. Each party is in possession of one of two copies of these forms. The forms are valid and effective for the agreement period of 5 years.
