



## **Announcement of the Graduate School, Chiang Mai University**

### **Subject: Criteria and Procedure for Graduate Scholarship Granted in ASEAN Community**

In order to support and develop studies and researches at a graduate level, especially students in ASEAN community countries, to build the national academic atmosphere and good relationships among students in ASEAN Community countries, the criteria and procedures of Graduate Scholarships for students in ASEAN Community Countries from the deposit of Graduate School Fund are offered.

#### **1. Applicant Qualifications**

- 1.1 Being a graduate student within the ASEAN Community, ASEAN member nationals, except Thai, and who has been selected to study at graduate level with the letter of acceptance from the Graduate School.
- 1.2 Achieve, GPA of not less than 3.00 (first semester exemption)
- 1.3 Student graduated in thesis-only program must have satisfactory research project according to the criteria that the supervisory committee or the Graduate School deem appropriate.
- 1.4 Applicants not registered as a student, but apply for the scholarship. Applicants use the admission acceptance letter in graduate level of Chiang Mai University or the letter of admission results.
- 1.5 During the study period of the course, not during the academic leave.

#### **2. Application Documents**

- 2.1 Application Form
- 2.2 A front facing photograph, 1 inch
- 2.3 A copy of every page of the passport
- 2.4 A copy of student card
- 2.5 A copy of transcription, except the first semester
- 2.6 A letter explaining reasons and necessity from advisor, department and/or faculty.

Applicants who apply follow to Number 1.4 must prepare the documents from Number 1.4 and only from number 2.1-2.3

#### **3. Type, engagement and evaluation criteria of the scholarship**

- 3.1 Scholarships covering tuition fee only.
- 3.2 Scholarship recipients have no engagement with the scholarship, do not pay back.
- 3.3 Scholarships provided follow the criteria considered by the committee made up by the Graduate School occasionally.

#### **4. Value and Duration of the scholarship**

- 4.1 Scholarships are for Master degree and Doctoral degree students.
- 4.2 Not less than 10 scholarships or the amount that the Graduate School deem appropriate.
- 4.3 Scholarships cover only tuition fee thorough the program according to the actual payment.
- 4.4 The Graduate School gives fund by paying the tuition fee directly to the finance division.

#### **5. Application and Consideration Period**

- 5.1 The announcement will be made on June or November, in case the scholarships are granted in the second semester.
- 5.2 The Graduate School will pay the tuition fee from the granted semester and follow to the payment period/deadline of the registration office.

#### **6. Termination of Scholarship**

- 6.1 No qualifications according to number 1.
- 6.2 Misbehavior towards oneself or university.
- 6.3 Cannot maintain at least 3.00 GPA during the course period.
- 6.4 Students enroll in the research-only programs; the presentation progress of the research has unsatisfactory results.
- 6.5 Other cases can be considered by the department, college, faculty, or the Graduate School for the termination of the scholarship.

#### **7. Judgment**

The final decision about the granting or terminating of scholarship is generally made by the Graduate School according to this announcement.
