Article I - Purpose of the Agreement

Article II - Collaboration

- Student exchanges. Every year 2-4 excellent students will be selected by FoL to complete their internships in Guangxi Sibei Law Firm for the duration of two four months. Guangxi Sibei Law Firm shall act as the host and provide the return air tickets and accommodation expenses for the interns, while the cost of living expenses shall be borne by the interns.
- Intellectual supports. The Thai-China Legal Service Center at FoL will provide intellectual supports to Guangxi Sibei Law Firm or Sibei (Thailand) Law Firm in its law-related endeavors.
- Knowledge and cultural exchanges. Both partners agree to conduct legal and cultural knowledge exchange activities.
- Graduates recommendation. The FoL may recommend promising graduates to submit their job applications to Sibei (Thailand) Law Firm.

Additional considerations pertaining to specific rights and obligations shall be negotiated separately by both partners.

Article V – Duration of the Agreement

The present Agreement will come into effect on the date of its signing by the authorities and will remain in force for a period of five years. It will automatically be renewed at regular intervals for the same period, however each party may move, in writing and with six months' notice to this effect, to amend or terminate the Agreement.
